

1 Report of the Education AR – 2018

2
3 The Immediate Past President shall be responsible for the supervision and direction
4 of the Area of Responsibility-Education. The Dental Education Program shall
5 reside in this area. Also, association matters pertaining to, but not limited to, oral
6 health education shall be in the area of Education.

7
8 The Dental Education Program provides Hawaii Dental Association members with
9 quality continuing dental education from internationally recognized speakers at a
10 reasonable cost. Additionally, it provides members the opportunity to visit over 100
11 exhibitors, who share the latest in dental products and services, and feature a full display
12 of state-of-the-art equipment and technology. Program Chair Dr. Jaclyn Lum and
13 program members help to plan, organize, and run The Hawaii Dental Association
14 Convention in January every year.

15
16 The Convention’s “Grant Model” offers \$3,000 per speaker to allow program planners
17 the flexibility to select speakers. This allows more leverage regarding the speakers, the
18 content of the lectures, and recourse in the event the speaker does not comply with the
19 contractual agreement.

21 2018’s convention included the Life Member Lunch and a visit from our ADA Executive
22 Director Kathleen O’Loughlin. HDA also co-sponsored our second ethics course with
23 TDIC at Kapiolani Community College just prior to the Convention. Around 230
24 members attended, to obtain their required state CE credits.

25
26 The 2019 CE Program is scheduled for April 11th and 12th, 2019 with five speakers
27 confirmed. This CE program will be a shortened version of our annual convention that
28 has been rescheduled from January 2019 due to ADA annual session in Hawaii for Oct.
29 18 – 22, 2018. For 2019, the Life Member Luncheon is scheduled for Thursday at 12
30 noon and the Women’s Breakfast will be postponed. The Dental Education Program is
31 also currently planning for 2020.

33 HDA received \$273,986.13 from ADA as reimbursement for impact to the revenue of the
34 2018 and 2019 HDA conventions, due to the ADA’s annual session presence in October
35 of 2018 in Honolulu.
