- Report of the HDA House of Delegates Reference Task Force 2021-H 1 2 3 The HDA Reference Task Force met on October 6th, 2021 via Zoom to review all Reports and 4 5 Resolutions for the HDA House of Delegates 2021. 6 7 The Task Force was comprised of eligible HDA delegates representing each Hawaii component society with one member from Hawaii County, one member from Maui County, one member 8 9 from Kauai County, and four members from Honolulu County; selected by the HDA Vice President, whose role is to Chair the Task Force and is a voting member. The HDA Treasurer 10 was present as a voting member. The HDA Speaker of the House was present as a non-voting 11 member. Technical support was provided by HDA Executive Director Ms. Kim Nguyen and 12 13 staff. 14 The meeting was conducted in two parts, first as a general open session with testimony taken 15 16 from guests or members of the Reference Task Force, and the second as a closed session for members of the Task Force only. 17 18 19 During the general open session there were HDA members, Program Chairs, members of the current ADA Delegation, and Board of Trustee members in attendance as guests. 20 21 22 The only items to hear testimony from membership were #2021-01 and #2021-02, both from the 23 Delegation Task Force. These two resolutions included changes to the HDA bylaws and policy manual. One testifier spoke in favor for the advancement of #2021-01. Three members presented 24 25 specific concerns to words, sentences, content, and the overall structure of both reports and 26 resolutions. Another member spoke to support the intent of #2021-01 and #2021-02. All testimony acknowledged varying levels of dissatisfaction with #2021-01 and #2021-02 as 27 28 written. The testimony was informative, lively, and lengthy. 29 30 After considering all testimony which included strong testimony to the impact of the changes in 31 term length, the process of replacement of a delegate, the overall clarity, and the relationship of both resolutions to each other, the Reference Task Force recommends both resolutions #2021-01 32 and #2021-02 be referred back to the Delegation Task Force to report for the 2022 HDA House 33 of Delegates. The Reference Task Force further recommends that the Delegation Task Force 34 35 invite outgoing ADA Delegation members Drs. Ed Cassella and Neil Nunokawa to its composition. Of note, the makeup of the Delegation Task Force will change after the conclusion 36 of the 2021 HOD, as previously defined: "The Task Force shall be composed of one member of 37 38 the ADA delegation selected by the members of the Delegation themselves; the HDA immediate past president; the HDA President-Elect; the HDA Vice President; the Young Dentist Program 39 chair or a representative selected by the program chair, and the maker of the original resolution, 40 if he chooses to serve; and Dr. Gary Yonemoto." 41 42 During the closed portion of the meeting, the Task Force voted on each report and resolution for 43
