1	Report of the HDA House of Delegates Reference Task Force –
2	2020
3	
4 5	The HDA Reference Task Force met on October 6, 2020 via Zoom to review all Reports and Resolutions for the HDA House of Delegates 2020.
6	
7 8	The Task Force was selected from a pool of eligible HDA delegates by myself, the Vice President, whose role is to Chair and is also a voting member. Each component society
9	was represented by at least one member of the Task Force.
10	
11	The meeting was managed in two parts, first as an open session with testimony and
12	comments taken from members of the Task Force or guests, and the second as a closed
13 14	session for members of the Task Force only. Technical support was provided HDA
14 15	Executive Director Ms. Kim Nguyen and staff.
16	During the testimony portion of the meeting there were various HDA members, Program
17	chairs and Board of Trustee members in attendance as guests. The title of each written
18	report and resolution was reviewed and the Chair asked for any comments or testimony.
19	report and resolution was reviewed and the chair asked for any comments of testimony.
20	The only resolution to hear testimony from membership was #2020-10 Selection of the
21	HDA Delegation to the ADA House of Delegates, in which two members spoke in favor
22	of proposed resolution, and four members spoke against. All but one testifier stated that
23	they would support the creation of a task force to review the selection of the ADA
24	Delegation and institution of term limits for ADA Delegates.
25	
26	The Reference Task Force has submitted a Substitute Resolution, #2020-10-RTF to
27	create such a task force.
28	
29	During the closed portion of the meeting, each report and resolution was voted upon for
30	approval/be adopted or rejected, substituted or deferred. The results of voting are as
